- SG Enable may reject any application that is incomplete or is not supported by the required documents specified or for any other relevant reasons.
- The completed application form must be signed by the applicant or the legal guardian if the applicant is below 21 years old and/or certified mentally incapacitated.

PROCESSING TIME:

- Upon receipt of the completed application form and all required supporting documents, SG Enable requires up to 15 working days to process the application.

ELIGIBILITY*^

- Singapore Citizen or Permanent Resident
- Aged between 7 and 60 years old
- Applicant must be certified by a medical practitioner to have any of the following permanent disabilities:
 - Physical Disability
 - Intellectual Disability
 - Visual Impairment
 - Hearing Impairment
 - Autism Spectrum Disorder

SUPPORTING DOCUMENTS

- Clear **photocopy of the applicant's NRIC** (Front and Back) or **Birth Certificate** (*if applicable*)
- Supporting documents on the applicant's **permanent disability**#:
 - **Latest doctor's memo** stating permanent disability; or
 - **Functional Assessment Report** to be completed by a doctor for assessment of physical disability. (Functional Assessment Report can be obtained from www.sgenable.sg)
- **Photograph of the applicant** for the personalised concession card:
 - One passport-sized colour photograph taken within the last three months
 - If the photograph is submitted via email, the resolution must be 240 X 320 pixels
 - The photograph must be taken in sufficient light against a white background and clearly show the full front view of the face

SUPPORTING DOCUMENTS

(If the applicant is below 21 years old and/or certified mentally incapacitated)

- Supporting documents proving the relationship between Parent/Legal Guardian and the Applicant:*
- Photocopy of the Applicant's Birth Certificate
- Photocopy of NRIC (Front and Back) of Parent/Legal Guardian
- For Donee(s) acting under a Lasting Power of Attorney granted by the Applicant or Deputy(s) appointed by the Court under the Mental Capacity Act (Cap. 177A) to act on the behalf of the Applicant:**
- Photocopy of NRIC (Front and Back) of Donee(s) / Deputy(s)
- Photocopy of the Registered Lasting Power of Attorney / Order of Court

Applicant/ medical institutions will be required to clarify and/or provide additional documentary proof of disability and /or any other relevant document at SG Enable's request.

* PwDs who are below 7 years of age, students (Primary, Secondary, Junior Colleges, ITE, Special Education schools) and Senior Citizens need not apply as they are already covered under existing concession schemes.

^ PwDs holding on to Diploma Student Concession Cards, Undergraduate or NSF Concession Cards are permitted to hold both their existing and new concession cards.

* The consent will expire once the Applicant reaches 21 years of age.
